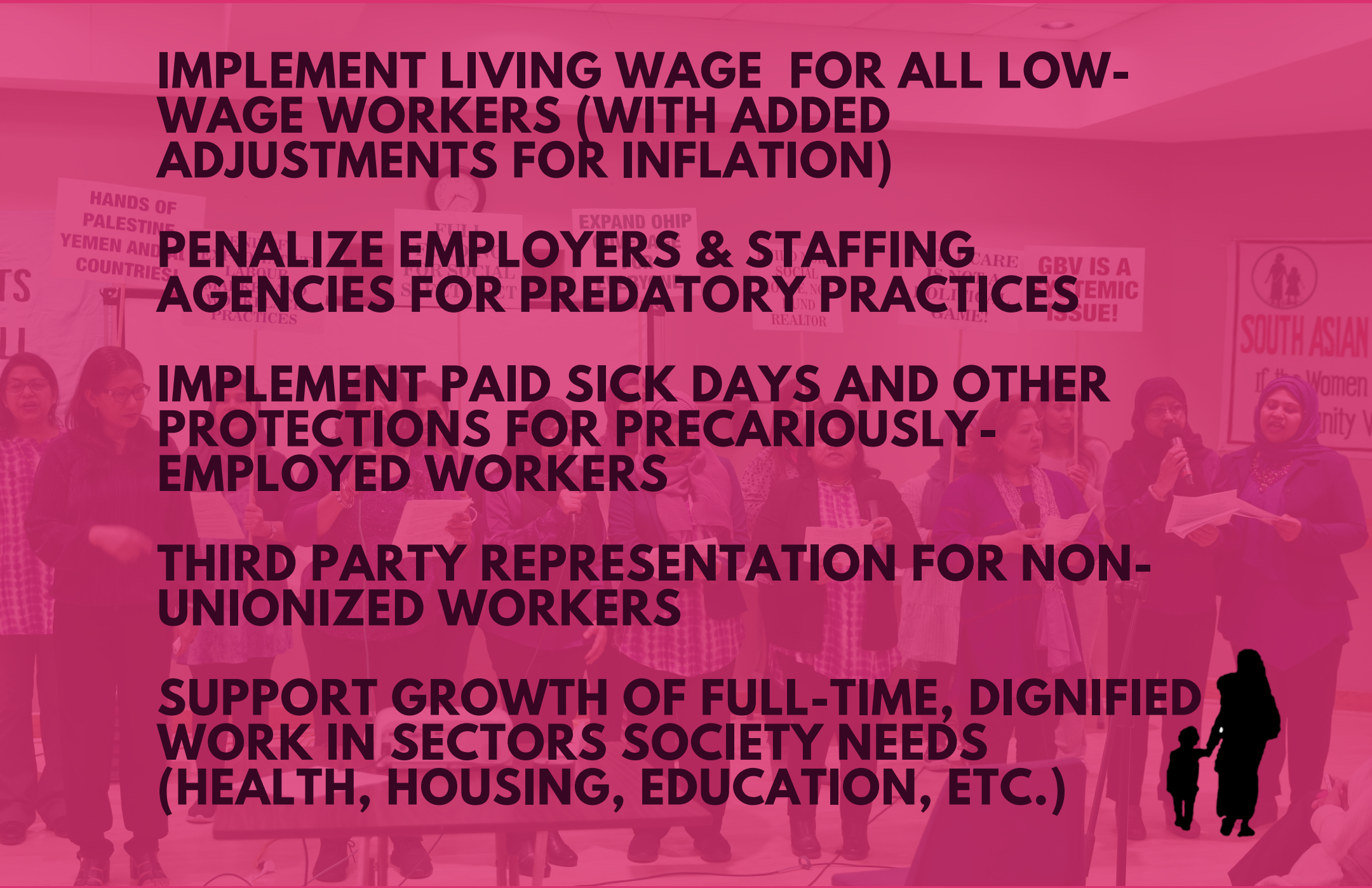

RECOGNIZE HOUSING AS A HUMAN RIGHT AT ALL-LEVELS OF GOVERNMENT

PRIORITIZE SOCIAL HOUSING AS THE PRIMARY STRATEGY FOR DELIVERING AFFORDABLE AND ADEQUATE HOUSING

FOCUS ON INCREASING ACCESS TO SOCIAL HOUSING FOR LOW-INCOME FAMILIES AND INDIVIDUALS FACING HOMELESSNESS & VIOLENCE

STRONGER PROTECTIONS FOR RENTERS (RENT REDUCTION/FREEZE, END RENT-STACKING AND RENOVICTIONS, PROTECTIONS FOR SUBLETTERS, ETC.)
